#### ORDER:-

Pursuant to the orders of the Supreme Court of India first read above, orders were issued in the Government Order second read above constituting District Level Vigilance Committee and State Level Scrutiny Committee to scrutinise the genuineness of the community certificates issued as Scheduled Castes and Scheduled Tribes respectively.

- 2. Further, in the Government Order third read above, orders were issued constituting four Regional Vigilance Cells at Chennai, Salem, Tiruchirappalli and Madurai regions to verify the community status of the persons belonging to Scheduled Castes and Scheduled Tribes and to submit report to the District Level Vigilance Committee and State Level Scrutiny Committee.
- 3. Now, in compliance with the orders of the Supreme Court of India first read above, the Government decided to issue the following amendments to Government Order (MS) No. 106, Adi Dravidar and Tribal Welfare (CV 1) Department, Dated 15.10.2012:-

## **AMENDMENTS**

In the said Government Order, in paragraph 10,

(i) in sub-paragraph (iii), for the expression "submit a report to the District Level Vigilance Committee / State Level Scrutiny Committee", the expression "submit a report to the District Level Vigilance Committee / Director, Tribal Welfare" shall be substituted;

- (ii) in sub-paragraph (iv),-
  - (a) for the expression "District Level Vigilance Committee / State Level Scrutiny Committee", the expression "District Level Vigilance Committee / Director, Tribal Welfare" shall be substituted; and
  - (b) for the expression "competent committee" in two places where it occurs, the expression "District Level Vigilance Committee / Director, Tribal Welfare" shall be substituted.
